To be eligible to compete in the event cars must be AWSR registered and the driver must be a member of an AWSR affiliated club and raced at least three meetings in the past 12 months. Competitors are required to forward the completed form to the above address. Entries are accepted once payment has been received.

Format:

- Scrutineering from 12 noon – 50 Points awarded for nominated car being in the pits and ready for Scrutineering prior to 2pm
- 3 heats per car (10 Laps)
- Top 16 Qualifiers directly to A-Main (25 Laps)
- Qualifiers 17-32 to the B-Main (15 Laps) with the top 4 finishers transferring to the rear of the A-Main (Plus 2 emergencies being fifth and sixth placing from the B-Main)
- Qualifiers 33-48 to the C-Main (12 Laps) with the top 2 finishers transferring to the B-Main
- Qualifiers 49-64 to the D-Main (12 Laps) with the top 2 finishers transferring to the C-Main

Nomination Fee:

- \$100 per car – Nominations close Friday February 3, 2012
- Late Nomination Fee of \$200 per car after close of business Friday February 2, 2012 (and will also be placed rear of field for heats)
- Nomination Fee will include Transponder Hire for the night

Trophies and Prizes:

- Trophies and Sashes for 1st, 2nd and 3rd placing in the A-Main
- 1st - \$2000 / 2nd - \$1000 / 3rd - \$750 / 4th - \$500 / 5th - \$400 / 6th-10th \$250 / \$200 to start (11th-20th)
- All other competitors \$100
